Education Scotland – Inspection of Papdale Primary School.

Report by Corporate Director for Education, Leisure and Housing.

1. Purpose of Report

To advise of the findings of the recent Education Scotland inspection of Papdale Primary School undertaken in May 2023.

2. Recommendations

The Committee is invited to note:

2.1.

That, in May 2023, a team of inspectors from Education Scotland visited Papdale Primary School, being the first full inspection of any school in Orkney since before the COVID-19 pandemic.

2.2.

That, during a full model inspection, four key quality indicators from How Good is Our School are used in a standard inspection, with the evaluations of these quality indicators for Papdale Primary School as follows:

- Leadership of Change satisfactory.
- Learning, Teaching and Assessment good.
- Ensuring Wellbeing, Equality and Inclusion satisfactory.
- Raising Attainment and Achievement good.

2.3.

That, as a result of the positive inspection visit, HM Inspectors are confident in the school's capacity to continue to improve and as such they will make no more visits to the school in connection with this inspection.

2.4.

The inspection letter in respect of Papdale Primary School, attached as Appendix 1 to this report, issued by Education Scotland on 27 June 2023, together with next steps outlined in section 5 of this report, in order to obtain assurance.

3. Background

3.1.

In May 2023, a team of inspectors from Education Scotland visited Papdale Primary School. This is the first full inspection of any of the schools in Orkney since before the COVID-19 pandemic.

3.2.

The newly appointed head teacher had been in post for four weeks prior to the inspection week.

3.3.

2022/23 was the first full session of learning that had not experienced significant disruption during the last three years. Nationally learning was disrupted from March 2020 to June 2021 with two full lockdowns and restrictions placed on what could be done within schools to minimise mixing. During session 2021/22, there were many challenges with a high degree of absences from children and staff as the COVID-19 outbreak really impacted across Orkney's schools during this time and there were times when some classes had to close, including those at Papdale Primary School.

4. Summary of Inspection

4.1.

The following key strengths were identified:

- Children are polite, respectful and very proud of their school. They take part in learning activities with enthusiasm and are eager to contribute their ideas to improve their school.
- Children benefit from positive and mutually respectful relationships with staff. This underpins the supportive climate for learning where children feel valued, known as individuals, and nurtured.
- Staff use effective approaches to improve children's literacy skills. These are improving attainment in literacy outcomes for children.

4.2.

The following areas for improvement were identified:

- Senior leaders should continue to develop their approaches to evaluating and improving the work of the school. They should involve all members of the school community more regularly in improving the work of the school.
- Teachers should continue to develop a shared understanding of high-quality learning, teaching and assessment. This will help to ensure that children experience high-quality learning and teaching across the school.
- Staff should develop a shared language of wellbeing to support children more consistently to discuss and improve their wellbeing.

 Staff should develop children's understanding of the importance of equality, valuing diversity and difference in society, and challenging discrimination. This will help children develop respect and understanding for others.

5. Summary and Next Steps

5.1.

The areas for improvement, outlined in section 4.2 above, will be taken forward by the school as part of the school improvement planning process and will feature on the plan for Papdale over the next few years to ensure that they are embedded in practice.

5.2.

Local Authority officers will continue to engage with the staff team to monitor and support the improvements identified.
