Education, Leisure and Housing Committee: 10 September 2025. ISLANDS Council Co

Report by Director of Education, Communities and Housing.

1. Overview

- 1.1. As a Schoolcare Accommodation Service, Papdale Halls of Residence, is regulated by the Care Inspectorate.
- 1.2. Papdale Halls of Residence staff provide daily care and support to young people between the ages of 11-19 years from the outer isles so that they can access education within Kirkwall Grammar School.
- 1.3. Papdale Halls of Residence had an unannounced inspection by the Care Inspectorate on 6 and 7 May 2025 with the report, attached as Appendix 1, published on 29 May 2025.
- 1.4. Papdale Halls of Residence was last inspected on 14 and 15 August 2024 and one area was inspected, 'How well do we support children and young people's rights and wellbeing', which received an adequate grading.
- 1.5. The Care Inspectorate is tasked with identifying weaknesses in service provision, non-compliance with legislation or suggestions for improvement.
- 1.6. Each inspection focuses on different areas and associated Health and Social Care Standards and Social Care and Social Work Improvement Scotland (Requirements for Care Services) Regulations 2011 ("the 2011 Regulations").
- 1.7. During the inspection in May 2025 one area was re-visited and considered:
 - How well do we support children and young people's rights and wellbeing?
- 1.8. The following key messages were identified:
 - Almost all young people felt safe and supported by staff who showed compassion and warmth to young people in their care.

- There was improved communication with partners.
- The provider's updated safeguarding procedures were nearing completion.
- There was commitment from managers to ensure improvement to safeguarding practices.
- Medication practices had improved.
- Personal plans for young people contained SMART (specific, measurable, achievable, realistic and timebound) outcomes.
- The physical environment was vibrant and welcoming.
- The quality of meals and snacks continued to be of a high standard.
- 1.9. The Service was given a Good grading.
- 1.10. The report is positive and the Care Inspectorate were content that any previous requirements and recommendations had been met during this inspection.
