## Council Tax Charges plus Scottish Water

### – water and waste water charges

### 2023/24



The Council Tax for the financial year 2023/24, to be set in accordance with Section 93 of the Local Government Act 1992, is set at £1,369.21 for a property in Valuation Band D – a 10% increase from 2022/23.

Scottish Water’s water and waste water charges have increased by 5% for 2023/24. Orkney Islands Council is not responsible for setting the water and waste water charges but must bill and collect these charges on behalf of Scottish Water. The amount payable will be reduced if a property is not connected to these services.

Each property is given a Council Tax Valuation Band, between A and H, based on its open market value as at 1 April 1991. The Council Tax charge for each Valuation Band is based on a proportion of the Band D amount.

## Council Tax plus Scottish Water charges 2023/24

The following table shows how much will be payable for a household with two or more persons aged 18 years or over.
