# 3. Orkney's Community Wind Farm Project

Following a presentation from Sweyn Johnston on the background to Orkney's Community Wind Farm project, together with the latest details in respect of the proposed wind farm at Quanterness, for which a planning application was due to be submitted in early 2020, together with an update from Kirsty Groundwater on the latest meetings held as part of the pre-application process, it was:

Resolved to note the contents of the presentations.

# 5. Matters Arising

## A. Shrub Bed at Scapa Junction

There was no further update from Cathleen Hourie on proposed financial assistance towards the shrub bed at the Scapa junction.

## **B. Traffic Issues at Watersfield Development**

After hearing an update from Councillor David Dawson on traffic issues at the Watersfield Development, it was:

Resolved to note that following a public meeting held in October 2019 for residents within the area, it had been agreed that, for a trial period, a section of Burnett Brae, between Watersfield and Weyland, would be closed to see what effect that would have on traffic patterns in the immediate and surrounding areas.

### C. Bridle Path at Inganess

Following consideration of correspondence from Orkney Islands Council advising of works completed to the stile and handrail near Wideford Farm and provision of an additional boardwalk over a muddy section, copies of which had been circulated, it was:

Resolved to note that the damaged boardwalk still required repair however due to livestock being kept in the area, together with the recent wet conditions, no work would be done until it dried out and that the farmer would be contacted regarding the grazing of sheep in particular, given the damage caused to a section of the core path.

### D. Bonfire and Fireworks Display at Pickaquoy

Resolved to thank all those who turned up, on the rescheduled date, to help steward the event which was considered to be a success.

### E. Arcadia Park

After hearing an update from the Chair on the visit to Arcadia Park on 24 November 2019, it was:

Resolved to commend the work undertaken to date, noting that a lot of work was still to be done before the project was complete.

### F. 2019 Review of Electoral Arrangements

Following consideration of a news release issued on behalf of the Local Government Boundary Commission for Scotland regarding the 2019 review of electoral arrangements within the three island council areas, copies of which had been circulated, it was:

Resolved to note that the consultation on proposals for amending the boundaries in the Kirkwall wards, including taking Kirkwall airport into the Kirkwall East ward, closed on 2 December 2019.

Resolved that the Clerk should write to Orkney Islands Council advising that the Community Council was generally in support of the proposed development, and that members could, if they so wished, submit their own individual responses.

### D. Care Home – Kirkwall

Following consideration of correspondence from local residents regarding the delay in progressing the new care home in Kirkwall, copies of which had been circulated, it was:

Resolved to note the latest position with regard to the development and planning of the proposed new care home to be sited in Kirkwall.

# 7. Policy on Financial Assistance

Following consideration of proposals from the Finance Sub-committee regarding a review of the policy on financial assistance, copies of which had been circulated, it was:

Resolved that the following policy be adopted, with effect from 1 April 2020:

- 1. Grant assistance for travel within Orkney to be removed.
- 2. The per capita grant to be reduced from £30 to £20.
- 3. The tiered approach reduced to three levels, as follows:
- Up to 10 people £20 per person.
- 11 to 15 people total grant of £225.
- 16 or more people total grant of £275.
- 4. The policy applies to persons aged 18 years and under (resident within the community council area).
- 5. Any application from a person aged over 18 years will be considered on individual merit.
- 6. Only applications from constituted groups will be considered (see exception at 8 below for regional or national squads).
- 7. Maximum grant to be claimed in any financial year to be capped at £275 (reduced from £400).
- 8. Individuals attending training/competitions as part of a regional or national squad (i.e. not Orkney-based) to continue to be offered £10 for each session attended, capped at £100 in any financial year.
