Pickaguoy Centre Trust – End of Year Performance.

Report by Executive Director of Education, Leisure and Housing.

1. Purpose of Report

To review Pickaquoy Centre Trust's end of year usage and performance for 2017 to 2018.

2. Recommendations

The Committee is invited to note:

2.1.

Pickaquoy Centre Trust's end of year usage figures and performance from 2017 to 2018, attached as Appendix 1 to this report, which indicate the following:

- Overall annual usage figures of 463,611 which represents an overall increase of 9% in usage against the same period in 2016 to 2017.
- The main positive variances against targets being gym (including strength and conditioning), group exercise, health suite and spa, other indoor leisure, swimming, climbing and bouldering, soft play, campsite, and sport courses.
- The main negative variances against targets being all-weather pitch use, junior activities, arena sports, cinema, squash, track and infield and grass pitches.

2.2.

That Pickaquoy Centre Trust's annual accounts for 2017 to 2018 have been submitted and indicate an operating deficit of £324,623.

3. Background

3.1.

The agreement for the provision of services, known as the Service Agreement forms the basis of the contractual arrangement between the Council and the Pickaquoy Centre Trust. It is based on the requirement in terms of section 14 of the Local Government and Planning (Scotland) Act 1982 for the Council to ensure there is adequate provision for the facilities for the inhabitants of their area for recreational, sporting, cultural and social activities.

3.2

The Council has agreed to make payments to the Pickaquoy Centre Trust for the supply of services as detailed in the Service Agreement. The amount paid for the services is reviewed annually to determine the requisite annual payment for the agreed level of service provision.

3.3

Officers from the Education, Leisure and Housing Services and the Change Programme are working in partnership to review the Service Agreement between the Council and the Pickaquoy Centre Trust, in doing so ensuring it is a more robust and detailed document.

4. Monitoring of Pickaguoy Centre Performance

4.1.

The Council reviews the management fee on an annual basis taking into account the financial settlement and level of service required. The management fee paid by the Council for 2017 to 2018 was £792,600.

4.2.

A comparison has been made with actual usage for the previous years, as detailed in Appendix 1 to this report, which indicates a positive variance of 9% in overall usage of the Pickaquoy Centre.

4.3.

The main positive variances in usage figures are in the gym (including strength and conditioning), group exercise, health suite and spa, other indoor leisure, swimming, climbing and bouldering, soft play, campsite and sport courses. The main negative variances against target are all-weather pitch use, junior activities, arena sports, cinema, squash, track and infield and grass pitches.

4.4.

Performance data for 2017 to 2018 show that a number of areas experienced significant growth in usage with other areas decreasing slightly and overall usage of 463,611 is a year increase in usage of 9%.

4.5.

An analysis of the actual usage figures compared with the same period in 2017 to 2018 indicate that the areas of activity showing the largest increases are as follows:

- Gym (including strength and conditioning) up by 13%.
- Group exercise up by 28%.
- Health suite and spa up by 36%.
- Other outdoor leisure up by 37%.

- Climbing and bouldering up by 22%.
- Indoor soft play up by 8%.
- Swimming up by 11%.
- Sports courses up by 24%.
- Campsite up by 15%.

4.6.

Analysis of the usage figures also highlight some areas of operation where there has been little or no growth on the previous year, these include:-

- Grass pitches down by 1%.
- Junior activities down by 8%.
- Arena sports down by 10%.
- Cinema down by 11%.
- All weather pitch down by 24%.
- Track and infield down by 6%.
- Squash down by 7%.

4.7.

The commentary on the variances between 2017 to 2018 usage against 2016 to 2017 actuals has been submitted by the Pickaquoy Centre Trust and is attached as Appendix 2 to this report.

4.8.

The annual accounts for the period 2017 to 2018, have been submitted and indicate an operating deficit of £324,623. Increases in operating expenditure exceeded the growth in income that arose primarily from the ActiveLife Scheme. The main contributory factors for the deficit are due to a 16% (£218,000) increase in staff costs and a 57% (£77,000) increase in purchases for resale.

5. Corporate Governance

This report relates to governance and performance monitoring processes and procedures and therefore does not directly support and contribute to improved outcomes for communities as outlined in the Council Plan and the Local Outcomes Improvement Plan.

6. Financial Implications

6.1.

The Council paid the Pickaquoy Centre Trust a management fee of £792,600 for 2017 to 2018 to deliver a range of services, subject to the performance targets as set out within the Service agreement being met.

6.2.

In accordance with the Code of Guidance on Funding External Bodies and Following the Public Pound, the Council has a duty to ensure adequate stewardship of Council funds at all times. It should be viewed as good practice that the Council ensures that the necessary systems and controls are in place to protect its investment.

7. Legal Aspects

The Purpose of the Service Agreement is to provide fiscal savings, and in addition gives the Council the opportunity to monitor the Pickaquoy Centre Trust on performance management principles.
