## Local Government (Scotland) Act 1973 – Schedule 7A

### **Access to Information: Descriptions of Exempt Information**

Paragraph 6. Information relating to the financial or business affairs of any particular person (other than the authority).

Paragraph 14. Any action taken or to be taken in connection with the prevention, investigation or prosecution of a crime.
