**Education Scotland – St Andrews Primary School.**

**Report by Director of Education, Communities and Housing.**

## **1. Overview**

- 1.1. In May 2025, Education Scotland undertook an inspection of St Andrews Primary School. This was a short model inspection.
- 1.2. The inspection team found the following strengths in the school's work:
  - The welcoming inclusive ethos where the school values are evident in the positive relationships across the school. Children make positive contributions to the work and life of the school and to the creative heritage of their community.
  - The effective approaches to improving learning and teaching across the school. The headteacher has worked very well with staff to improve the quality and consistency of children's learning experiences at all stages.
  - The whole school approach to improving attainment in writing. Children are highly motivated and enjoy writing. There is clear evidence of improved outcomes for children across the school.
- 1.3. The following areas for improvement were identified and discussed with the Headteacher and the Service Manager (Primary Education):
  - Continue to raise the attainment of all children with a focus on improving outcomes in numeracy and mathematics.
  - Continue to develop approaches to learning and teaching with an increased focus on providing children with increased challenge in their learning and developing their creativity skills.
- 1.4. The evaluations given to the quality indicators for the primary school are as follows:
  - Learning, Teaching and Assessment -good.
  - Raising attainment and achievement – good.

- 1.5. HM Inspectors are confident in the school's capacity to continue to improve and will make no more visits in connection with this inspection.
- 1.6. The areas for improvement, outlined above, will be taken forward by the school as part of the school improvement planning process and features on the plan for St Andrews Primary School over the next year to ensure that the priorities are developed and embedded in practice.

Dear Parent/Carer

In May 2025, a team of inspectors from Education Scotland visited St Andrew's Primary School. During our visit, we talked to parents/carers and children and worked closely with the headteacher and staff.

The inspection team found the following strengths in the school's work.

- The welcoming, inclusive ethos where the school values are evident in the positive relationships across the school. Children make positive contributions to the work and life of the school and to the creative heritage of their community.
- The effective approaches to improving learning and teaching across the school. The headteacher has worked very well with staff to improve the quality and consistency of children's learning experiences at all stages.
- The whole school approach to improving attainment in writing. Children are highly motivated and enjoy writing. There is clear evidence of improved outcomes for children across the school.

The following areas for improvement were identified and discussed with the headteacher and a representative from Orkney Islands Council.

- Continue to raise the attainment of all children with a focus on improving outcomes in numeracy and mathematics.
- Continue to develop approaches to learning and teaching with an increased focus on providing children with increased challenge in their learning and developing their creativity skills.
