Proposed Prohibition of Waiting - Palace Road, Kirkwall.

Report by Executive Director of Development and Infrastructure.

1. Purpose of Report

To consider objections following statutory and public consultation in relation to The Orkney Islands Council (Palace Road, Kirkwall) (Prohibition of Waiting) Order 2019.

2. Recommendations

The Committee is invited to note:

2.1.

That, in July 2018, the Council agreed that waiting on the north side of Palace Road, Kirkwall, be restricted to one hour, between 08:00 and 18:00, Mondays to Saturdays.

2.2.

That several letters of objection, from residents and users of facilities on Palace Road, were received during the consultation process in respect of the proposal referred to at paragraph 2.1 above, as summarised in Appendix 1 to this report.

2.3.

The proposal that waiting restrictions on Palace Road, Kirkwall, be amended as follows:

- The proposed single yellow line on the south side of Palace Road being amended to a double yellow line.
- Waiting on the north side of Palace Road being amended from one hour to two hours.

2.4.

That, should the proposal referred to at paragraph 2.3 above be agreed, a further period of consultation will require to be carried out, as it would introduce more stringent restrictions than previously proposed.

It is recommended:

2.5.

That the Executive Director of Development and Infrastructure undertake a further period of consultation in respect of the proposed amended waiting restrictions on Palace Road, Kirkwall, referred to at paragraph 2.3 above.

3. Background

3.1.

Concerns raised regarding parking on Palace Road, Kirkwall, relate to inconsiderate parking, obstruction of access and visibility, lack of parking provision and the lack of enforcement. These concerns have been echoed by elected members, local businesses and other road users.

3.2.

At its meeting held on 5 June 2018, the Development and Infrastructure Committee recommended that waiting on the north side of Palace Road, Kirkwall, be restricted to one hour, between 08:00 and 18:00, Mondays to Saturdays.

4. Engagement and Consultation

4.1.

Consultation on the proposals has taken place with the following:

- Road Haulage Association Limited.
- Freight Transport Association.
- Scottish Fire and Rescue Service.
- Disabled Drivers' Association.
- Orkney Disability Forum.
- Scottish Ambulance Service.
- NHS Orkney.

4.2.

The proposals were advertised publicly in accordance with the statutory requirements to consult.

4.3.

Police Scotland has confirmed its support for the proposals in the interests of road safety.

4.4.

Several objections were received. These are summarised and attached as Appendix 1 to this report.

4.5.

The objections predominately came from two different groups, firstly from users of the facilities on Palace Road, who were concerned that:

- One hour parking is not long enough and that this should be increased to two hours.
- The seven day restriction on parking should be reduced to six days, allowing parking on both the north and south sides on a Sunday.
- The parking restriction on a Sunday restricts access to the church for elderly people.

4.6.

The second of group of objections came from residents on Palace Road who expressed concerns, as follows:

- Parking on the south side of the road makes it difficult to cross the road and use driveways due to restricted visibility.
- The time limit restriction of 08:00 to 18:00 is not long enough. Palace Road is still congested until about 21:00.
- Double yellow line instead of single yellow line on the south side.
- One hour is not long enough for the designated parking spaces on the north side.
- Why is there a need for a bus stop on Palace Road? Remove the bus stop and add a further four to five parking spaces.

4.7.

The objectors were advised that following the consultation and the objections raised, officers would consider the following:

- The parking layout and time limits will remain the same as shown on the original plan.
- The parking layout will remain the same as the original plan. However, the
 proposed single yellow line on the south side of Palace Road would be changed
 to a double yellow line and the parking time limits in the spaces on the north side
 of Palace Road would be extended from one hour to two hours.
- The parking layout will remain the same as the original plan. However, the proposed single yellow line on the south side of Palace Road would be enforced Monday to Saturday, 08:00 to 18:00, and the parking time limits in the spaces on the north side of Palace Road would be extended from one hour to two hours.

4.8.

Having considered the objections, it is proposed that the parking layout remain the same as the original plan; however the proposed single yellow line on the south side of Palace Road would be changed to a double yellow line and the parking time limits in the spaces on the north side of Palace Road would be extended from one hour to two hours, as shown on the drawing attached as Appendix 2 to this report. If agreed, this will require the consultation process to begin again as this option introduces more stringent restrictions than previously proposed. These proposals address concerns raised by both sets of objectors.

5. Options

5.1.

The options open to the Council are:

- To proceed with original proposals and make the order,
- To make the order with modifications and start the consultation process again.
- Not to make the order, in which case the status quo is maintained.

5.2.

The Council is permitted to make the order with modifications, provided these do not extend the application of the order or impose more stringent restrictions.

5.3.

It is recommended to commence a further consultation process on the proposed amended waiting restrictions on Palace Road, Kirkwall, for the reasons outlined at section 4.8 above.

6. Equalities Impact

An Equality Impact Assessment has been undertaken and is attached as Appendix 3 to this report.

7. Corporate Governance

The report relates to governance and procedural issues and therefore does not directly support and contribute to improved outcomes for communities as outlined in the Council Plan and the Local Outcomes Improvement Plan.

8. Financial Implications

As Roads Authority, the cost of any Traffic Regulation Order, estimated at about £1,000, will be borne by the Council under the relevant section of the roads revenue budget. In this instance given the complexity of the review there have been additional costs due to the increased amount of time Roads officers have spent on the project.

9. Legal Aspects

If the Council wishes to introduce new parking restrictions, it must obtain a traffic regulation order under the Road Traffic Regulation Act 1984. The requirements of The Local Authorities' Traffic Orders (Procedure) (Scotland) Regulations have been observed as regards the form of the order and the procedure to date.


