Noted:

- **13.1.** That the Notice of Motion was procedurally competent, in that:
- It was received in the requisite timeframe.
- It was signed by an Elected Member and countersigned by at least one other Elected Member.
- It was accompanied by a report from the Interim Executive Director of Environmental, Property and IT Services on the implications of the suggested course of action contained in the Notice of Motion.

Councillor John T Richards joined the meeting at this point.

After consideration of a report by the Interim Executive Director of Environmental, Property and IT Services, copies of which had been circulated, and after hearing a report from the Interim Head of Roads, Fleet and Waste, the Council:

Noted:

- **13.2.** That, in 2003, the Scottish Government made funding available for the creation of safer routes to schools which subsequently led to the introduction of part-time 20 mph speed limits around some schools in Orkney, as detailed in section 4 of the report by the Interim Executive Director of Environmental, Property and IT Services.
- **13.3.** That there was no identified budget to introduce 20 mph part-time speed limits at the island schools, estimated to be £478,000.
- **13.4.** That, on 16 February 2017, when reviewing speed limits at island schools, the Development and Infrastructure Committee resolved, in terms of delegated powers, that, subject to availability of funding, mandatory, variable part-time 20 mph speed limits be introduced at the following island schools:
- North Walls Junior High School.
- Sanday Junior High School.
- Stronsay Junior High School.
- Westray Junior High School.
- Shapinsay Primary School.
- Rousay Primary School.
- Eday Primary School.
- Papa Westray Primary School.
- **13.5.** That the Development and Infrastructure Committee also recommended that the Executive Director of Development and Infrastructure should progress a Stage 1 Capital Project Appraisal in respect of a phased programme for the introduction of mandatory, variable part-time 20 mph speed limits in the vicinity of island schools.

- **13.6.** That, in order to accommodate the timescale for introducing 20 mph part-time speed limits at the island schools as required by the Notice of Motion, existing planned programmes of work for 2022/23 would be significantly impacted.
- **13.7.** The options for progressing the project to introduce variable part-time 20 mph speed limits around island schools, should the Notice of Motion be supported, as detailed in section 6 of the report by the Interim Executive Director of Environmental, Property and IT Services.

The Council considered the Notice of Motion and thereafter resolved:

- **13.8.** On the motion of Councillor Stephen G Clackson, seconded by Councillor John T Richards, to install, as soon as practicable but no later than the end of 2023, a 20mph zone or speed limit on the roads in the vicinity of each of those schools in Orkney that still did not have one.
- **13.9.** On the motion of Councillor James W Stockan, seconded by Councillor Robin W Crichton, that, in order to progress the project to install a 20 mph zone or speed limit around island schools, Option 1, namely the submission of a Stage 1 Capital Project Appraisal to the Development and Infrastructure Committee, be adopted.

1. Regeneration Capital Grant Fund – Birsay Heritage Trust

After consideration of a report by the Interim Executive Director of Finance, Regulatory, Marine and Transportation Services, copies of which had been circulated, and after hearing a report from the Development and Regeneration Manager, the Sub-committee:

Noted:

- **1.2.** That, in June 2021, the Council submitted a Stage One application to the Scottish Government's Regeneration Capital Grant Fund, on behalf of Birsay Heritage Trust, in respect of repairing the deteriorating historic structures at HMS Tern and providing heritage interpretation, at a total estimated project cost of £1,170,122.
- **1.3.** That, on 15 September 2021, the Scottish Government's Regeneration Team advised that the application from Birsay Heritage Trust had passed the Stage One assessment and that submission of a Second Stage application was invited by 22 October 2021.

The Sub-committee resolved, in terms of delegated powers:

- **1.4.** That the Council should submit a Second Stage application to the Scottish Government's Regeneration Capital Grant Fund on behalf of Birsay Heritage Trust.
- **1.5.** That, in the event of the application attracting an offer of grant from the Regeneration Capital Grant Fund, powers be delegated to the Interim Executive Director of Finance, Regulatory, Marine and Transportation Services, in consultation with the Head of Finance and the Solicitor to the Council, to accept/decline the offer of grant and, if accepted, enter into an appropriate legal agreement with Birsay Heritage Trust.

2.2. That, on 15 September 2021, the Scottish Government's Regeneration Team advised that the application from North Ronaldsay Trust had passed the Stage One assessment and submission of a Second Stage application was invited by 22 October 2021.

The Sub-committee resolved, in terms of delegated powers:

- **2.3.** That the Council should submit a Second Stage application to the Scottish Government's Regeneration Capital Grant Fund on behalf of North Ronaldsay Trust.
- **2.4.** That, in the event of the application attracting an offer of grant from the Regeneration Capital Grant Fund, powers be delegated to the Interim Executive Director of Finance, Regulatory, Marine and Transportation Services, in consultation with the Head of Finance and the Solicitor to the Council, to accept/decline the offer of grant and, if accepted, enter into an appropriate legal agreement with North Ronaldsay Trust.
