1. Apologies

3. Update from Chief Officer, Orkney Health and Care

The Chair welcomed Orkney Health and Care's Chief Officer, who was in attendance to provide an update on ongoing projects and consultations. The meeting heard that Orkney Health and Care (OHAC) were planning to be in attendance at all the agricultural shows this summer and in the foyer at Tesco's to try and engage directly with individuals and communities on the draft OHAC Strategic Plan consultation. The Chief Officer explained the consultation to members and, following discussion on various health topics, it was:

B. Evie School Front Door and Fire Foyer Door

Members heard that the timing of the front door at Evie School had been extended to allow more time to enter and leave the building and that the sticking fire door within the foyer had been fixed, and it was:

C. Fire Exit from Community Room of Evie School

Following reports of concern that the only steps at the new Evie School build were situated at the fire exit of the Community room, it was:

Resolved to highlight this matter to the relevant department at Orkney Islands Council.

J. Mrs W Pickles – Planning Concerns

Members considered correspondence received from Mrs W Pickles, copies of which were distributed at the meeting, regarding her concerns to changes to planning rules. Following a lengthy discussion, members agreed that the amendments to the rules seemed to be prohibiting single builds and they would prefer to see larger development sites broken-down into smaller sites, and it was:

Resolved for the comments made to be included in the response to the Housing in the Countryside Supplementary Guidance consultation.

Ms L Wilson left the meeting at this point.

8. Consultations

A. Housing in the Countryside Supplementary Guidance

Following consideration of the consultation on the Supplementary Guidance on Housing in the Countryside, copies of which had previously been circulated, and discussion thereof, it was resolved:

- 1. To note that the deadline for submission of comments was that day.
- 2. That responses by members to the Consultation questions be conveyed to Democratic Services.
- 3. To also note that the changes were making it very difficult for individuals wishing to build on a single site only. Members were of the opinion that fewer clusters in the countryside would be ideal, with individual sites for non-developers or building companies.

- 4. To also note that the plot system only works for developers of multiple properties.
- 5. To note that Evie was the only parish where no housing provision had been made even though land had been allocated for building.

B. Draft Orkney Harbours Masterplan Phase 1

Following consideration of the Consultation on the draft Orkney Harbours Masterplan Phase One, copies of which had previously been circulated, it was:
