Education, Leisure and Housing Committee: 10 September 2025. Education Scotland - Dounby Primary School Nursery.





1. Overview

- 1.1. In February 2025, an inspector from Education Scotland undertook an inspection of Dounby Nursery. This was a full inspection and all four quality indictors from How Good is our Early Learning and Childcare were received.
- 1.2. The inspection team found the following strengths in the nursery's work:
 - Nursery managers guide and lead improvement well. Practitioners reflect on and develop their practice through professional learning and from taking on leadership roles. This is impacting positively on children's outcomes.
 - Practitioners are highly responsive to children's interests and ideas. They offer children meaningful opportunities to make decisions about their learning and the nursery environment. This helps children deepen their learning and develop new skills.
 - Practitioners plan and provide a range of interesting and varied experiences
 within the nursery and in the local community. As a result, children are
 motivated, curious and eager to learn. This supports children to make good
 progress across the curriculum.
 - Practitioners are skilful in their interactions with children and provide nurturing support and encouragement. This is helping to build children's independence, confidence and wellbeing.
- 1.3. The following areas for improvement were identified:
 - Nursery managers should continue to develop their self-evaluation processes.
 This should include making clearer the leadership roles and responsibilities of senior staff.
 - Nursery managers and practitioners should continue to develop approaches to check children's progress in their learning. They can also support practitioners to make further use of national Benchmarks to help inform their professional judgements.

- 1.4. The four key quality indicators from How Good is our Early Learning and Childcare were evaluated as follows:
 - Leadership of change Good.
 - Learning Teaching and Assessment Very Good.
 - Ensuring Wellbeing, Equality and Inclusion Good.
 - Securing Children's Progress-Good.
- 1.5. The report was very positive and the managers and practitioners at Dounby Nursery will continue to develop their practice alongside the early years team.

Appendix 1 –Inspection Report

Dear Parent/Carer

In February 2025, a team of inspectors from Education Scotland visited Dounby Community School Nursery. During our visit, we talked to parents/carers and children and worked closely with the nursery managers and staff.

The inspection team found the following strengths in the nursery's work.

- Nursery managers guide and lead improvement well. Practitioners reflect on and develop their practice through professional learning and from taking on leadership roles. This is impacting positively on children's outcomes.
- Practitioners are highly responsive to children's interests and ideas. They offer children meaningful opportunities to make decisions about their learning and the nursery environment. This helps children deepen their learning and develop new skills.
- Practitioners plan and provide a range of interesting and varied experiences within the nursery and in the local community. As a result, children are motivated, curious and eager to learn. This supports children to make good progress across the curriculum.
- Practitioners are skilful in their interactions with children and provide nurturing support and encouragement. This is helping to build children's independence, confidence and wellbeing.

The following areas for improvement were identified and discussed with the nursery managers and a representative from Orkney Islands Council.

- Nursery managers and practitioners should continue to develop approaches to check children's progress in their learning. Nursery managers can also support practitioners to make further use of national Benchmarks to help inform their professional judgements.
