Further Information about this form

From 1 April 2012 to March 2026 rates relief is available to businesses within defined geographic Enterprise Areas. One of the four defined Enterprise Areas in Scotland is the Low Carbon / Renewable North Enterprise Area that covers Hatston (Orkney) and Lyness (Orkney).

Activities that give rise to eligibility for rates relief are the design, fabrication, manufacture and assembly of components required for the generation of renewable energy by the technologies described in Schedule 2 of the Renewables Obligation (Scotland) Order 2009, including foundations and substructures (fixed or floating), towers, blades and nacelles, and research and development connected to those activities.


